Written motion was made by Commissioner Ballenger and seconded by Commissioner Wise that the minutes of the regular meeting of October 5, 2015 be approved as submitted. On roll call vote, Commissioners Wise, Ballenger, Crang and Mayor Cyrulik voted "Yes".

The bills and payroll were read.

Written motion was made by Commissioner Wise and seconded by Commissioner Crang that the bills and payroll be allowed as read and the Clerk be instructed to issue warrants on the Treasurer for the several amounts. On roll call vote, Commissioners Ballenger, Crang, Wise and Mayor Cyrulik voted "Yes".

REPORT FROM THE DEPARTMENT OF PUBLIC PROPERTY

REPORT FROM THE DEPARTMENT OF PUBLIC HEALTH & SAFETY

Written motion was made by Mayor Cyrulik and seconded by Commissioner Crang to approve the purchase of Bulk Road Salt for the Street Dept. from Midwest Salt in the amount of \$20,400.00. On roll call vote, Commissioners Ballenger, Crang, Wise and Mayor Cyrulik voted “Yes”.

Written motion was made by Mayor Cyrulik and seconded by Commissioner Wise to approve the purchase of Turnout Gear for the Fire Dept. from AEC in the amount of \$1,715.00. On roll call vote, Commissioners Crang, Wise, Ballenger and Mayor Cyrulik voted “Yes”.
