Minutes of the regular meeting of the City Council of the City of Clinton, Illinois in session in the Council Chambers of City Hall, Monday, October 17, 2016 at 7:00 p.m. Mayor Roger Cyrulik, presiding. On roll call, Commissioners Edmunds, Crang and Wise were present. Commissioner Ballenger was absent.

Written motion was made by Commissioner Wise and seconded by Commissioner Edmunds that the minutes of the regular meeting of October 3, 2016 be approved as submitted. On roll call vote, Commissioners Wise, Edmunds and Mayor Cyrulik voted "Yes". Commissioner Crang voted "Present".

The bills and payroll were read.

Written motion was made by Commissioner Edmunds and seconded by Commissioner Crang that the bills and payroll be allowed as read and the Clerk be instructed to issue warrants on the Treasurer for the several amounts. On roll call vote, Commissioners Wise, Edmunds, Crang and Mayor Cyrulik voted "Yes".

REPORT FROM THE DEPARTMENT OF STREETS & PUBLIC IMPROVEMENTS

Commissioner Crang had no report.

REPORT FROM THE DEPARTMENT OF PUBLIC PROPERTY

Commissioner Wise reported the department had a water main break on Saturday and apologizes for the boil order. He also thanked the Street Dept. for the summer projects in making the streets look nice. He stated that the Hospital looks very nice and also commented on how well the Youth Initiative Program is for those students involved and that they are able to attend Richland Community College for two years for free if they so choose.

REPORT FROM THE DEPARTMENT OF PUBLIC HEALTH & SAFETY

Assistant Fire Chief Jason Karr reported they will start training on a house fire in Kenney through the instruction of the University of Illinois.

UNFINISHED BUSINESS

Written motion was made by Mayor Cyrulik and seconded by Commissioner Wise to approve the Contract and Demolition Bid from Krumsiek Excavating for 117 W. Webster St. in the amount of \$27,600.00. On roll call vote, Commissioners Edmunds, Crang, Wise and Mayor Cyrulik voted "Yes".

Written motion was made by Mayor Cyrulik and seconded by Commissioner Crang to adopt Ordinance #1415, An Ordinance Authorizing Sale of Personal Property Owned by the City of Clinton, Illinois (1998 Chevrolet C7500 Dump Truck/Street Dept.). On roll call vote, Commissioners Crang, Wise, Edmunds and Mayor Cyrulik voted "Yes".

Written motion was made by Mayor Cyrulik and seconded by Commissioner Edmunds to approve the Purchase of 16 sets of Turn Out Gear from Municipal Emergency Services for the Fire Dept. in the amount of \$2,548.00 for each set. On roll call vote, Commissioners Wise, Edmunds, Crang and Mayor Cyrulik voted "Yes".

Written motion was made by Mayor Cyrulik and seconded by Commissioner Wise to adopt Ordinance #1416, An Ordinance Authorizing Sale of Personal Property Owned by the City of Clinton, Illinois – Hospital (Misc. items). On roll call vote, Commissioners Edmunds, Crang, Wise and Mayor Cyrulik voted "Yes".

Written motion was made by Mayor Cyrulik and seconded by Commissioner Crang to adopt Ordinance #1417, An Ordinance Authorizing Acquisition of Real Estate – the DeWitt County Human Resource Center West in the amount of \$175,000.00. On roll call vote, Commissioners Crang, Wise, Edmunds and Mayor Cyrulik voted "Yes".
