Minutes of the regular meeting of the City Council of the City of Clinton, Illinois in session in the Council Chambers of City Hall, Monday, November 5, 2018 at 7:00 p.m. Acting Mayor Tom Edmunds, presiding. On roll call, Commissioners Wise, Ballenger, Edmunds and Crang were present. Mayor Cyrulik was absent.

Written motion was made by Commissioner Crang and seconded by Commissioner Wise that the minutes of the regular meeting of October 15, 2018 be approved as submitted. On roll call vote, Commissioners Ballenger, Edmunds, Crang and Wise voted "Yes".

Written motion was made by Commissioner Wise and seconded by Commissioner Crang to adopt Ordinance #1486, An Ordinance Authorizing the Execution of the Illinois Municipal League Risk Management Association Minimum/Maximum Contribution Agreement in the amount of \$224,599.65. On roll call vote, Edmunds, Crang, Wise and Ballenger voted "Yes".

The bills and payroll were read.

Written motion was made by Commissioner Ballenger and seconded by Commissioner Wise that the bills and payroll be allowed as read and the Clerk be instructed to issue warrants on the Treasurer for the several amounts. On roll call vote, Commissioners Crang, Wise, Ballenger and Edmunds voted "Yes".
