Remaining on the agenda from Oct. 13<sup>th</sup> meeting – Purchase from CDS Office Tech – 2 CR Tough Books - \$10,094 (Fed Grant Paying \$7,500).

Council will consider this purchase at a recess of our regular meeting on Wednesday, Oct. 21<sup>st</sup> at noon so that the Grant can be applied for before the end of the month.

Chief Reidy reported that when they applied for the Grant back in June there was no match of Federal dollars – however now they are going to award a 25% match to a \$10,000 Grant.

The second item on file for the Police Dept. will be the purchase of 2 CF Docking Stations from CDS Office Tech.- in the amount of \$1,450. The department's docking stations are outdated.
