## **ROLL CALL, MINUTES, BILLS & PAYROLL**

Minutes of the regular meeting of the City Council of the City of Clinton, Illinois in session in the Council Chambers of City Hall, Monday, Oct. 4, 2010. Mayor Ed Wollet, presiding. On roll call Commissioners Edmunds, Hickman, Wise and Milton were present

Written motion was made by Commissioner Hickman and seconded by Commissioner Wise to approve the minutes of the public hearing on annexation held Sept. 20, 2010 at 6:45 p.m. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Written motion was made by Commissioner Milton and seconded by Commissioner Wise that the minutes of the regular meeting of Sept. 20<sup>th</sup> 2010 be approved as submitted. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

The bills and payroll were read.

Written motion was made by Commissioner Edmunds and seconded by Commissioner Milton that the bills and payroll be allowed as read and the Clerk be instructed to issue warrants on the Treasurer for the several amounts. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Mayor Wollet announced various events that are coming up soon in our community including the 100 car pile up this weekend and the Hospital Gala will be Oct. 16<sup>th</sup>.

## **REPORT FROM THE DEPARTMENT OF STREETS & PUBLIC IMPROVEMENTS**

Commissioner Hickman reports that the Fall City Wide Cleanup will be held this Saturday from 8:00 a.m. to 12:30 p.m. and the yard waste facility will also close at 12:30 p.m. that day.

Street closures will include the downtown square for the Fire Truck Parade dusk until 10:00 p.m. South Jackson by Lincoln Grade School will be closed for the Fire Prevention Education Week.

East Washington St. near the Haunted House area will be closed various evenings for the tours.

## **REPORT FROM THE DEPARTMENT OF PUBLIC PROPERTY**

Commissioner Wise said that the process for installation of the Filter Media will be done in two parts for a safety issue rather than all at once. He continued with discussion about the Waterworks Plant maintenance that is continuing each day to keep the plant up to par.

## **REPORT FROM THE DEPARTMENT OF PUBLIC HEALTH & SAFETY**

Commissioner Milton asked Chief Reidy to report about the car show coming to the downtown square both Fri & Sat. Anywhere between 200 to 500 hot rod and classic cars may come Decatur where the main show will take place on Saturday. With extra officers on duty they will control the entrance and exits on and off the square. Snappers will be taking control of the consumption of alcohol only on their premises.

Fire Chief Shawn Milton said that Fire Prevention Week kicked off at Douglas School including a host of activities like the Fire Truck Parade with possibly 27 trucks.

The renovation of the benches and tables on Mr. Lincoln Square turned out very nice with staff putting in considerable time to complete the project.

## **REPORT FROM THE DEPARTMENT OF ACCOUNTS & FINANCES**

Commissioner Edmunds had no report at this time.

## **UNFINISHED BUSINESS**

Written motion was made by Commissioner Wise and seconded by Commissioner Hickman to approve the proposal to clean the Lime Lagoon at the Waterworks Plant in the amount of \$60,000. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

On File – Award Contract for Televising & Cleaning Sewers – Hunter Hydro-Vac \$48,002.55.

The Clerk announced that she will be receiving petition packets from the County Clerk's Office soon. Circulation can begin now but filing dates are not until Dec. 13<sup>th</sup> thru Dec. 20<sup>th</sup> 2010.
