# REPORT FROM THE DEPARTMENT OF STREETS & PUBLIC IMPROVEMENTS

Commissioner Hickman reports that the yard waste facility will close until Saturday due to the snow and water making it hard to get into the facility.

He also thanked the other departments for stepping up during the time the street department was short on help for snow removal.

## REPORT FROM THE DEPARTMENT OF PUBLIC PROPERTY

## **UNFINISHED BUSINESS**

Written motion was made by Commissioner Hickman and seconded by Commissioner Wise to authorize the purchase of 15 City Flags from Minerva Promotions at a cost of \$1,200 plus shipping & handling. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Written motion was made by Commissioner Milton and seconded by Commissioner Edmunds to approve the purchase of 2 moving radar guns from Decatur Electronics in the amount of \$3,580. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Written motion was made by Commissioner Edmunds and seconded by Commissioner Hickman to approve Under the Prairie Stars Summer Concert Series for 2008 in the amount of Kavan \$3,000 – Ruby Wilson \$3,000 – Boat Drunks Jimmy Buffet Party \$1,750 and Frank Sinarta \$3,750. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Written motion was made by Commissioner Edmunds and seconded by Commissioner Wise to adopt Ordinance #1115, an Ordinance Granting Special Use (DeWitt-Piatt Bi-County Health Dept.). On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Written motion was made by Commissioner Edmunds and seconded by Commissioner Milton to approve an amendment to the Miller Façade Agreement, 213 E. Main St. in the amount of \$1,420. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Written motion was made by Commissioner Edmunds and seconded by Commissioner Hickman to approve the purchase of a new voice mail system from Verizon in the amount of \$2,605.48. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

## **NEW BUSINESS**

On File – Budget Amendment for Hospital – Purchase of an Anesthesia Monitor \$22,730.23 – this replaces a piece of equipment that is 15 years old with a demo model.

On File – Water Main Extensions – an Engineering Agreement Farnsworth Group – not to exceed \$80,000. Three areas will have lines extended – Extend water line north on 51 bypass and cross over to North Fertilizer – a line from 1400 E. Main to the Elks Lodge will complete a loop and BFI to Miller Container will complete another loop.

## **CLOSED SESSION**

Written motion was made by Commissioner Hickman and seconded by Commissioner Edmunds to hold a closed session for the purpose of imminent litigation and collective bargaining. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."
