# **REPORT FROM THE DEPARTMENT OF ACCOUNTS & FINANCES**

Commissioner Edmunds did have better news that last month the sales tax was up slightly from last year at this time. Hopefully the trend is changing.

## **UNFINISHED BUSINESS**

Written motion was made by Commissioner Hickman and seconded by Commissioner Milton to adopt Resolution #2009-13, Resolution authorizing execution of an Intergovernmental Agreement between City of Clinton, Illinois and Clinton Community School District #15 (Outdoor LED Matrix Display \$20,000). On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Written motion was made by Commissioner Hickman and seconded by Commissioner Milton to approve the purchase of 3 Dell Computers for Police Dept. \$2,399.85 and 1 Dell for the Street Dept. \$878.23. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Last item for unfinished business – MACTEC Engineering for evaluating the City Sewer System. This will provide 2 parts – first being inspection of our system and the second part next spring will be renting and installing flow meters in various locations. This might help to narrow the search to find where the infiltrations are getter into our systems causing backup to basements.

Mayor Wollet expressed concern with spending money on studies that could possibly go toward the expense of repairing the system. Commissioner Hickman said that we need the direction of where and how much we will need for this project before beginning the process.

Written motion was made by Commissioner Hickman and seconded by Commissioner Edmunds to approve a MACTEC Engineering Agreement Sewer System Evaluation \$111,325 per Exhibit A of the Master Agreement dated Sept. 6, 2005. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

### **NEW BUSINESS**

On File – Bids for Landscaping at City Hall – apparent low bid – Jason's Lawn Service \$13, 895.09

On File – Exemption for 6 locations during Apple & Pork 9/26/ - 9/27/09

On File – Electrical Lighting for the Landscaping Plan – not to exceed \$4,000

### **CLOSED SESSION**

Written motion was made by Commissioner Hickman and seconded by Commissioner Wise to hold a closed session for the purpose of Acquisition of Property. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Written motion was made by Commissioner Hickman and seconded by Commissioner Wise to recess until 5:00 p.m. August 25, 2009. On roll call Commissioner Edmunds, Hickman, Wise and Milton voted "Yes." Mayor Wollet voted "No"
