Mayor Wollet opened the public information session, which is not required by law because the levy increase is below the 5%. He then turned the hearing over to Commissioner Edmunds, Accounts and Finances.

The projected increase in the levy -4.72%. The major increases are in two areas - Police Pension fund mandated by the State of Illinois and the other in the Garbage Fund for the leaf removal program started a year ago. After briefly going through some of the relevant levy information, Commissioner Edmunds offered to take any questions or comments.

Hearing none, motion was made by Edmunds and seconded by Milton to adjourn the public session. Motion was unanimous.

With the boy scouts present this evening, everyone enjoyed the visit. Mayor Wollet read a press release from Aug. 16th 2008 detailing an event that happened at Weldon Springs State Park. Taking part in this heroic event was Wesley Scogin and Hunter Jolly who were fishing with a friend Kurt Oakley when Kurt suddenly lost consciousness and started to fall into the water. Both summoned help from Scout leader Welby Scogin and son Austin Scogin pulling Kurt to safety. These troops showed characteristics that the Scouts teach and promote in life each day. Written motion was made by Commissioner Milton and seconded by Commissioner Edmunds to purchase a used pickup truck from Anderson Ford in the amount of \$8,850. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."

Written motion was made by Commissioner Milton and seconded by Commissioner Wise to purchase the GSA System (Blackboard Connect Inc.) in the amount of \$6,494. On roll call Commissioners Edmunds, Hickman, Wise, Milton and Mayor Wollet voted "Yes."
