Commissioner Wise reported on the bill for the computer at the Water Plant and discussed the labor part of the bill. The company did reduce the bill and asked Council to approve the labor part of the bill.

Written motion was made by Commissioner Wise and seconded by Commissioner Edmunds to approve the Labor portion of the Automatic Systems Co. invoice in the amount of \$2,959.53. On roll call vote, Commissioners Crang, Wise, Milton, Edmunds and Mayor Peters voted "Yes".

Commissioner Wise also reported there have been a lot of water main breaks and the employees fix them as they happen. He stated the City does not have funds to upgrade the mains to try to reduce the problem.

On roll call vote, Commissioners Edmunds, Crang, Wise, Milton and Mayor Peters voted "Yes".
