Written motion was made by Commissioner Wise and seconded by Commissioner Crang that the minutes of the regular meeting of March 2, 2015 be approved as submitted. On roll call vote, Commissioners Milton, Edmunds (electronically), Crang, Wise and Mayor Peters voted "Yes".

The bills and payroll were read.

Written motion was made by Commissioner Edmunds and seconded by Commissioner Milton that the bills and payroll be allowed as read and the Clerk be instructed to issue warrants on the Treasurer for the several amounts. On roll call vote, Commissioners Edmunds (electronically), Crang, Wise, Milton and Mayor Peters voted "Yes".

She also stated that Congressman Rodney Davis will have a staff member here at City Hall on March 18^{th} from 1:00 p.m. -3:00 p.m. The Mayor along with the Clerk and the City Administrator went to the Aggregation Bid meeting on March 12^{th} and locked in the rate of .0569 for 36 months.

REPORT FROM THE DEPARTMENT OF ACCOUNTS & FINANCES

Commissioner Edmunds reported that Sales Tax YTD is down \$1,827.00.

UNFINISHED BUSINESS

Written motion was made by Commissioner Wise and seconded by Commissioner Edmunds to approve Resolution 2015-2, Resolution Authorizing Funding for the DeWitt County Development Corporation (DCDC) in the amount of \$47,000.00 beginning May 1, 2015. Commissioner Edmunds requested that DCDC provide the City with a Balance sheet/Income Statement next year. On roll call vote, Commissioners Wise, Edmunds (electronically) and Mayor Peters voted "Yes". Commissioners Crang and Milton voted "No".

Written motion was made by Commissioner Edmunds and seconded by Commissioner Crang to approve an Intergovernmental Agreement between the City of Clinton and DeWitt County Emergency Management Agency (EMA) for \$15,000.00, which will be paid in four quarterly installments of \$3,750.00. On roll call vote, Commissioners Wise, Milton, Edmunds (electronically), Crang and Mayor Peters voted "Yes".

Written motion was made by Commissioner Edmunds and seconded by Commissioner Milton to approve Resolution 2015-3, A Resolution Authorizing Execution of Acceptance of Assignment of Collateral by Pinehurst Development, Inc. to Nancy K. Brady. On roll call vote, Commissioners Milton, Edmunds (electronically), Wise and Mayor Peters voted "Yes". Commissioner Crang abstained.

NEW BUSINESS

Upon the reading of the Resolution by Mayor Peters, written motion was made by Commissioner Milton and seconded by Commissioner Edmunds to approve Resolution 2015-4, Resolution Urging the Governor and General Assembly to Protect Full Funding of Local Government Distributive Fund Revenues. On roll call vote, Commissioners Edmunds (electronically), Crang, Wise, Milton and Mayor Peters voted "Yes".

Written motion was made by Commissioner Crang and seconded by Commissioner Wise to approve the Contract with Richard Parker for the Stump Grinding in the amount of \$4,982.00. On roll call vote, Commissioners Crang, Wise, Milton, Edmunds (electronically) and Mayor Peters voted "Yes".

Written motion was made by Commissioner Edmunds and seconded by Commissioner Milton to approve a Raffle License for Clinton Community YMCA with their event to be held Tuesday, March 24, 2015 at the Copper & Brass Room. On roll call vote, Commissioners Wise, Milton, Edmunds (electronically), Crang and Mayor Peters voted "Yes".

Written motion was made by Commissioner Milton and seconded by Commissioner Crang to approve a Raffle License for D.A.R.E. with their event to be held Monday, April 6, 2015 at the Clinton United Methodist Church. On roll call vote, Commissioners Milton, Edmunds (electronically), Crang, Wise and Mayor Peters voted "Yes".
