## September 8, 2015

Minutes of the regular meeting of the City Council of the City of Clinton, Illinois in session in the Council Chambers of City Hall, Tuesday, September 8, 2015. Mayor Roger Cyrulik, presiding. On roll call, Commissioners Ballenger, Edmunds, Crang and Wise were present.

Written motion was made by Commissioner Crang and seconded by Commissioner Wise that the minutes of the regular meeting of August 17, 2015 be approved as submitted. On roll call vote, Commissioners Edmunds, Crang, Wise, Ballenger and Mayor Cyrulik voted "Yes".

The bills and payroll were read.

Written motion was made by Commissioner Edmunds and seconded by Commissioner Ballenger that the bills and payroll be allowed as read and the Clerk be instructed to issue warrants on the Treasurer for the several amounts. On roll call vote, Commissioners Crang, Wise, Ballenger, Edmunds and Mayor Cyrulik voted "Yes".

## PETITIONS AND COMMUNICATIONS

Representatives from Altorfer (CAT) and Martin Tri-State Construction Equipment Co. (John Deere) addressed the Council regarding the Backhoe purchase for the Water Dept.

Written motion was made by Mayor Cyrulik and seconded by Commissioner Ballenger to approve the Purchase of a Backhoe (CAT 416F2 ST) for the Water Dept. from Altorfer in the amount of \$74,430.00. On roll call vote, Commissioners Wise, Ballenger, Edmunds, Crang and Mayor Cyrulik voted "Yes".

# REPORT FROM THE DEPARTMENT OF STREETS & PUBLIC IMPROVEMENTS

Commissioner Crang wanted to thank Steve & Dana Lobb for the Tour DeWitt held on August 29<sup>th</sup> and also wanted to thank the community for coming together on September 5<sup>th</sup> for a benefit at Cross Fit for Suicide Awareness. Written motion was made by Commissioner Ballenger and seconded by Commissioner Edmunds to appoint Jason Karr as Assistant Fire Chief. On roll call vote, Commissioners Edmunds, Crang, Wise, Ballenger and Mayor Cyrulik voted "Yes".

Commissioner Ballenger reported that he is not too far away from bringing a Fire Chief forward to Council. He also stated that a Fire Truck is being provided at the football games and they are donating their time for this.

Andy Edmunds, Volunteer Fireman addressed the Council regarding Fire Prevention at the schools and different locations around town and was asking Council for a donation to help pay for the materials they pass out to the children at the schools. He also stated that the Fire Truck Parade is October 7<sup>th</sup> at 7:00 p.m.

On roll call vote, Commissioners Ballenger, Edmunds, Crang, Wise and Mayor Cyrulik voted "Yes".
