On roll call vote, Commissioners Edmunds, Crang, Wise, Ballenger and Mayor Cyrulik voted "Yes".

Written motion was made by Commissioner Ballenger and seconded by Commissioner Wise to adopt Ordinance #1402, An Ordinance Amending Section 7-1-6 of the City Code of the City of Clinton, Illinois (increased fees in the Cemtery for services after 3:00 p.m. and fee for inspection of a new foundation). On roll call vote, Commissioners Crang, Wise, Ballenger, Edmunds and Mayor Cyrulik voted "Yes".

Written motion was made by Mayor Cyrulik and seconded by Commissioner Crang to approve Resolution 2015-26, Resolution Authorizing Execution of an Intergovernmental Agreement Between City of Clinton, Illinois and DeWitt County, Illinois for the Purchase of Meals for Inmates (3 year contract). On roll call vote, Commissioners Wise, Ballenger, Edmunds, Crang and Mayor Cyrulik voted "Yes".
