Johnson St. and the City closed on the Spurgeon's Bldg. The Mayor had the City Treasurer run some numbers on the farm ground and it is doing well with the interest.

Written motion was made by Mayor Cyrulik and seconded by Commissioner Wise to approve the Grinding of Brush in the amount of \$13,150.00 and the Leaf Recycling in the amount of \$9,000.00 at the Yard Waste Facility by R & R Services of Illinois, Inc. On roll call vote, Commissioners Wise, Ballenger, Edmunds, Crang and Mayor Cyrulik voted "Yes".

Written motion was made by Commissioner Crang and seconded by Commissioner Edmunds to approve the 2016 Summer Concert Series. On roll call vote, Commissioners Ballenger, Edmunds, Crang, Wise and Mayor Cyrulik voted "Yes".
