Written motion was made by Mayor Cyrulik and seconded by Commissioner Edmunds to Reject the Bids from Waters Construction (\$60,090.00) and K & K Construction & Concrete (\$89,290.00) to build the Salt Storage Building for the Street Dept. On roll call vote, Commissioners Edmunds, Crang, Wise, Ballenger and Mayor Cyrulik voted "Yes".
