Minutes of the regular meeting of the City Council of the City of Clinton, Illinois in session in the Council Chambers of City Hall, Monday, November 7, 2016 at 7:00 p.m. Mayor Roger Cyrulik, presiding. On roll call, Commissioners Ballenger, Edmunds, Crang and Wise were present.

Written motion was made by Commissioner Wise and seconded by Commissioner Crang that the minutes of the regular meeting of October 17, 2016 be approved as submitted. On roll call vote, Commissioners Edmunds, Crang, Wise, Ballenger and Mayor Cyrulik voted "Yes".

Written motion was made by Commissioner Edmunds and seconded by Commissioner Ballenger to adopt Ordinance #1418, An Ordinance Authorizing the Execution of the Illinois Municipal League Risk Management Association Minimum/Maximum Contribution Agreement in the amount of \$217,426.77. On roll call vote, Crang, Wise, Ballenger, Edmunds and Mayor Cyrulik voted "Yes".

The bills and payroll were read.

Written motion was made by Commissioner Edmunds and seconded by Commissioner Crang that the bills and payroll be allowed as read and the Clerk be instructed to issue warrants on the Treasurer for the several amounts. On roll call vote, Commissioners Wise, Ballenger, Edmunds, Crang and Mayor Cyrulik voted "Yes".

PETITIONS AND COMMUNICATIONS

Annette McMath, a teacher from the Clinton School District and a representative of the Clinton Education Association, addressed the Council and then Mayor Cyrulik read the American Education Week Proclamation.

REPORT FROM THE DEPARTMENT OF PUBLIC AFFAIRS

Mayor Cyrulik had no report.

REPORT FROM THE DEPARTMENT OF STREETS & PUBLIC IMPROVEMENTS

Commissioner Crang reported that the leaf pick-up has started and the department will be working in zones. The citizens can go to the city's website and it will be posted daily what zone the crew is working in each day or they can call City Hall. She also stated that next week the Christmas decorations will start going up and the week of Thanksgiving the Christmas Tree will be put up for the Christmas Parade on Saturday, November 26th.

Public Works Director, Steve Lobb reported that the citizens need to rake the leaves out to the curb and don't mix brush and leaves together. They will also pick up leaves in the brown paper yard waste bags.

REPORT FROM THE DEPARTMENT OF PUBLIC PROPERTY

Commissioner Wise reported that the department flushed the mains last week and had one main break right in front of City Hall. He also stated that FEMA has some money available so the departments are making a "wish list" to turn into FEMA. He stated that he received a phone call from a citizen who would like to start a youth center and is looking for an empty building and would like to have a preliminary meeting in December and wanted the Council to be aware of it.

REPORT FROM THE DEPARTMENT OF PUBLIC HEALTH & SAFETY

Commissioner Ballenger reported that on Wednesday, November 2nd the DeWitt County Substance Abuse Coalition were able to have Tim Ryan "A Man in Recovery" speak at the schools and also to the public. He also stated that the Fire Dept. is making their "wish list" for FEMA.

Police Chief Ben Lowers reported also on the DeWitt County Substance Abuse Coalition that had a documentary made and was shown at one of the local churches and also had a panel for discussion and will be released at a later date to be seen by the public. He stated that this is one of the best things he has seen moving forward in the Clinton area.

Interim Fire Chief David Dallas reported the department had a successful Fire Prevention Parade with over 20 trucks and they had a Fire Safety Magic Show at the schools for the children.

REPORT FROM THE DEPARTMENT OF ACCOUNTS & FINANCES

Commissioner Edmunds had no report.
