#### REPORT FROM THE DEPARTMENT OF PUBLIC AFFAIRS

Mayor Peters discussed the Video Gaming Revenue/Sales and if they should be included in the gross sales for Bar & Grill and Restaurant Liquor classifications to determine compliance. The consensus of the Council was to not include that revenue in their yearly gross sales and Steve Myers, City Attorney was asked to provide language in the liquor ordinance to reflect this.

#### REPORT FROM THE DEPARTMENT OF PUBLIC PROPERTY

Commissioner Wise reported the department is flushing mains this week and locating shut-off valves buried under asphalt and gravel and getting them raised up to be accessible.

## REPORT FROM THE DEPARTMENT OF PUBLIC HEALTH & SAFETY

Commissioner Milton reported that on May 26<sup>th</sup> the Memorial Day program will be at 10:00 a.m. at the Cemetery. He also reported that the Fire Dept., the Red Cross and the

On roll call vote, Commissioners Wise, Milton, Edmunds and Mayor Peters voted "Yes".

Written motion was made by Mayor Peters and seconded by Commissioner Edmunds to approve a Yearly Raffle License for Dove, Inc. of Clinton from July 1, 2014 to June 30, 2015. On roll call vote, Commissioners Milton, Edmunds, Wise and Mayor Peters voted "Yes".

Written motion was made by Commissioner Edmunds and seconded by Commissioner Wise to approve a Yearly Raffle License for Kiwanis Club of Clinton, Illinois from July 1, 2014 to June 30, 2015. On roll call vote, Commissioners Edmunds, Wise, Milton and Mayor Peters voted "Yes".

Written motion was made by Mayor Peters and seconded by Commissioner Wise to reject the bid for the Illini Dr. Detention Basin Drainage Improvements. On roll call vote, Commissioners Wise, Milton, Edmunds and Mayor Peters voted "Yes".

- On File Bids for Main Street Sidewalk Project K & K Construction & Concrete \$21,096.72 and Quality Concrete (Don West) \$14,077.70 The replacement sidewalks will be on the north side of Suzi Davis Travel and in front of Round Again Sports.
- On File Bids for Abandonment of Well #9/Water Dept. Municipal Well & Pump \$7,898.00 and Layne Christensen Company \$8,750.00 According to state law the well has to be abandoned and filled with pea gravel and concrete.
- On File Bids for Inspection & Cleaning of 500,000 Gallon Water Tower/Water Dept. Water Tower Clean and Coat, Inc. \$7,000.00 and Midco Diving & Marine Services, Inc. & Ward's Pressure Washing \$8,557.36 The new water Tower will be inspected on the inside and cleaned on the outside.
- On File Bid for Leak Detection for Water System/Water Dept. Leak Detection Services, Inc. \$12,902.00 Our water leakage appears to be higher than the state's guidelines so the lines need to be tested to determine the location of the leakage.
- On File Bids for Schonstedt Magnetic Locator and Sure-Loc Multi-Frequency Locator/Water Dept. Pollard Water \$4,720.00 and USA Bluebook \$4,761.42 The magnetic locator finds the metal stop boxes and the other locator traces the lines and the mains.

Written motion was made by Commissioner Edmunds and seconded by Commissioner Milton to award the bid for Summer Maintenance 2014 to Illiana Construction A Division of Champaign Asphalt LLC in the amount of \$102,769.32. On roll call vote, Commissioners Milton, Edmunds, Wise and Mayor Peters voted "Yes".
