REPORT FROM THE DEPARTMENT OF STREETS & PUBLIC IMPROVEMENTS

Commissioner Buchanan reported the RR crossing on E. Jefferson St. is closed for repairs and should be back open by the end of the week. This week is brush pick-up and will start the new ordinance and the street employees will be going around town assessing the piles and giving people warnings and talking to them if they are home and if not they will leave a door knocker. They will pick up the brush this time but next month they won't if it is too large. Starting in December, January and February there will be no brush pick-up. The leaf vac will be out and the leaves need to be in the right-of-way and not in the street and they will pick up until the end of November. The new alley maintainer is in and they will start working in the alleys.

REPORT FROM THE DEPARTMENT OF PUBLIC PROPERTY

Commissioner Wise reported there is a piece of equipment at the Water Plant, which is the pump that puts the chlorine into the water system that has never worked right so they have a new one ordered and it is a newer type and will work much better and they will eventually order another one for a back-up.
