Mr. Redington stated the Fire Training Facility is over forty feet tall and it is against the code, and you can't burn in Clinton. Commissioner Ballenger stated it has been presented to the Council and the State Fire Marshal and it doesn't suit you and you don't like it. Mr. Redington asked what about you putting gas in your personal truck? I won't go away.

Written motion was made by Commissioner Wise and seconded by Commissioner Buchanan that the minutes of the regular meeting of May 2, 2023 be approved as submitted. On roll call vote, Commissioners Edmunds, Buchanan, Wise, Ballenger, and Mayor Cyrulik voted "Yes."

The bills and payroll were read.

# REPORT FROM THE DEPARTMENT OF STREETS & PUBLIC IMPROVEMENTS

Commissioner Buchanan reported the City is getting ready for May Days and there will be some street closures. The north half of the Square will be closed on Thursday evening and then Friday starting at 3:00 p.m. until Sunday the 100 Blocks of N. Center and E. Washington and the City parking lots. The City-wide Clean-up has been scheduled for June and July. A voucher (1 per household) can be picked up at City Hall if you live in the City Limits and show a valid driver's license for proof of residence. During the City-wide Clean-up, the Landfill hours are Monday – Friday 6:00 a.m. – 3:00 p.m. and one Saturday: July 8th 6:00 a.m. – 2:00 p.m. The department is picking up brush this week.

## REPORT FROM THE DEPARTMENT OF PUBLIC PROPERTY

Commissioner Wise reported the Street and Water Depts. got the concrete removed and some trees on N. Quincy St. where the house was torn down and will be bringing in some dirt and he thanked them for their work. The neighbors were happy. He stated there was an article in the Decatur Herald about Air BnB's and they charge a tax and permitting fees. People have them here in town so we as a Council need to decide if we are going to allow them or not. He also stated the screen in the Well was plugged up with mineral build-up and we received two bids and Layne Western was the low bid (\$23,000) and they had a cancellation and they are in town so they will be working on that tomorrow and lastly with all these Fiber Optic companies coming in and more waiting to come in the staff has worked on a utility permit that they will need to fill out and it will have a \$50,000 Bond put on it.

#### REPORT FROM THE DEPARTMENT OF PUBLIC HEALTH & SAFETY

Commissioner Ballenger reported that he got a call from Brandon Robinson that he found three leaf springs broken and took it to Heritage and they found the springs on the other side were broken also. He also stated the Fiber Optic company has hit several gas lines so we need some kind of control so the utility permit should help with that.

Police Chief Ben Lowers reported that with May Days going on there will be street closures and will have extra staff on duty and he wanted to invite everyone to the Retirement Open House for Mike Bennett on May 31<sup>st</sup> at the High School from 4:00 – 6:00.

## REPORT FROM THE DEPARTMENT OF ACCOUNTS & FINANCES

Commissioner Edmunds reported the Auditors are working at City Hall. He also stated the Sales Tax was \$9,000 more than this time last year.
