On roll call, Commissioners Buchanan, Wise, and Ballenger were present.

PUBLIC PARTICIPATION

Seth Redington addressed the Council and stated he was at the last Council meeting and there was a Public Hearing before that, and the meeting was only fifteen minutes and there were several people who wanted to talk, and they were cut short. It was to vacate Jemima Lane, and nothing has been done in the past two weeks. He wanted to know if he could park in front of his properties without being towed. When is something going to be done?

It has been three years that I have been asking for this to be a street and if I turn the lots east and west it will face the alley. It will have to be named and will it be white rocked? He stated another issue with the Street Dept. is there was a widow who posted on Facebook she had a pile of brush that was apparently too big for the City to pick up, so she was seeking help to get it picked up and taken to the Yard Waste. Mr. Redington stated the amount of brush fit in a pick-up truck. I helped pick that up tonight because that is the right thing to do. It is sad the City wouldn't help her out.

Commissioner Buchanan stated you keep changing your mind about what you wanted done with Jemima Lane. Mr. Redington stated I need access to my property and the City won't do anything.

Commissioner Edmunds stated the Public Hearing went over the time to start the Council meeting and I asked if there was anyone else who wanted to speak, and no one spoke up so the Public Hearing was adjourned. We will take everything under advisement.

Written motion was made by Commissioner Ballenger and seconded by Commissioner Wise that the minutes of the regular meeting of November 21, 2023 be approved as submitted. On roll call vote, Commissioners Wise, Ballenger, Buchanan, and Vice President of the Council Edmunds voted "Yes."
